

## **Aguettant Limited**

### **Transparency Disclosure 2022**

#### **Methodological Notes**

Aguettant Limited is not an ABPI member, however, the company has given formal agreement to abide by the ABPI Code of Practice and accept the jurisdiction of the PMCPA.

#### **Procedure**

The transfers of value which were considered for the 2022 disclosure are covered by Clauses 28 -31 of the ABPI Code of Practice 2021:

- joint working in accordance with Clause 20 of the ABPI Code of Practice 2021
- interactions with Health Professionals, Other Relevant Decision Makers, Healthcare Organisations, Patient Organisations and the Public, Including Patients and Journalists. Clauses 23-25 of the ABPI Code of Practice 2021
- sponsorship of attendance by health professionals and other relevant decision makers at meetings in accordance with Clause 10.10 of the ABPI Code of Practice 2021
- contributions towards the costs of meetings paid to healthcare organisations or to third parties managing events on their behalf, which may include sponsorship of health professionals by way of registration fees and accommodation and travel

Aguettant Limited contemporaneously record any transfers of value made by Aguettant Ltd, their parent Company and other affiliates to UK Healthcare Professionals (HCPs), Other Relevant Decision Markers (ORDMs) or Healthcare Organisation (HCO).

All transfer of value spends have been collated manually using a centralised spreadsheet. The records have been reconciled and confirmed internally a month before the disclosure to ensure the entirety of the transfers of value have been captured.

#### **Data Privacy**

Data Privacy law requires Aguettant Limited to obtain permission from individual HCPs or HCOs prior to disclosing personal data such as individual transfers of value. HCPs or HCOs have agreed on the transparency disclosure by signing their contracts with Aguettant Limited.

#### **Payment dates and reporting period**

Only payments made in 2022 are disclosed.

#### **Currency**

Where payments had been made in local currency other than GBP, the amount in GBP has been calculated using the published HMRC monthly exchange rate at the time the payment was made.
