

## **Mundipharma Research Limited methodology for disclosing Transfers of Value**

The details of the Transfers of Value (TOV), in accordance with the requirements of the ABPI Code of Practice are pulled together from our internal finance HCP/HCO/ORDM payment tracking systems. Data is then extracted to populate the template you will find here. This template is provided by the Prescription Medicines Code of Practice Authority (PMCPA) which administers The Association of the British Pharmaceutical Industry's (ABPI) Code of Practice. The amounts shown relate to payments corresponding to activities which took place between 1<sup>st</sup> January 2022 & 31<sup>st</sup> December 2022, including payments occurring up to the date of submission of this disclosure. This applies whether the payments are made directly, or indirectly through a third party. For multi-year contracts, the amounts shown will relate to activities that took place during the relevant time frame.

All payments are reported in pounds sterling. Where payments were made in other currencies e.g. Euros, Mundipharma Research Limited (MRL) has used its own internal currency exchange rate to convert the amount to the reporting currency. Details of these exchange rates are available on request. All amounts disclosed are exclusive of VAT.

Where possible, all TOVs will be disclosed on an individual basis. Consent to disclose is requested from HCP's, separately to individual contracts. Where recipients of TOVs have not consented to the disclosure of their identities, the amount attributable to such transfers will be disclosed on an aggregate basis. Those HCPs who have only consented partially, all TOVs, consented and not, are disclosed within the aggregate amount. The number of recipients involved will be stated together with the percentage of all recipients that they represent and the aggregate amount attributable to TOVs to such recipients.

MRL has an email address dedicated to the disclosure of TOVs that HCPs are able to send queries to.

### **Donations & Grants to HCO's**

Are defined as funding to Health Care Organisations or organisations at arms-length with no involvement from MRL. Support may take the form of money to support projects/initiatives, or charitable donations to a recipient who is lawfully authorised to receive donations.

### **Sponsorships**

Are defined as either when MRL has sponsored HCOs or organisations by funding an educational meeting, an educational event or educational congresses/conferences. These events are mainly organised by third parties and the recipient of the sponsorship has full responsibility for carrying out the activities with no involvement from MRL. Or this is when MRL has sponsored individuals to attend educational events or meetings in the UK and abroad. This can take the form of full or part funding towards registration fees, accommodation costs and travel expenses.

### **Fee for Services**

These are payment to individuals for services provided to MRL for activities such as consultancy or speaker engagement, chairing at meetings, training services, and participation in advisory boards meetings. Compensation for such services takes the form of payment of fees and may also include payment or reimbursement for reasonable accommodation costs and related travel expenses.

Contracts and agreements are completed on per activity basis to cover each activity separately.
