Activity	Methodology
General Comments	<p>The Pierre Fabre Ltd (PFL) disclosure for 2016 contains payments made for events & activities that took place in 2016.</p> <p>Late payments, i.e. payments made in 2017 for activities performed in 2016, are disclosed in this disclosure.</p> <p>Pre-payments; payment in 2016, for 2017 activity, i.e. international meeting registrations, are not disclosed in this disclosure but will be disclosed in the 2017 disclosure.</p>
Tax Consideration	<p>It is the responsibility of the recipient of funding/ payment, for the settlement of any taxes due.</p>
VAT	<p>VAT is not included for HCPs or individuals, i.e. fees/honoraria/sponsorship, however VAT is paid upon receipt of a VAT invoice i.e. some expense receipts include VAT. Also, for certain meetings i.e. stand meetings; VAT is paid when required.</p>
Currency	<p>Conversion rates are calculated at the rate, on the date of the event/activity/meeting.</p>
Data Privacy	<p>For individuals and organisations, our contracts state, that they will be named for ToV.</p>
Consent	<p>Consent is obtained per activity. Consent for named disclosure is captured in our letters of contract both for individuals and organisations and for each activity/event/meeting.</p>
Multi-Year Contracts	<p>N/A for 2016 except for clinical trials.</p>

Co-Marketing Projects	N/A for 2016 no co-marketing activity
Cross Border Payments	The payment of funds is disclosed in the country where recipients principle practice is. Details of the recipient, event and funding are forwarded by the PFL UK Office to the Pierre Fabre Office in the country of the recipient.
Over the counter TOV's	N/A – No activity.
Medical Device TOV's	N/A – No activity.
MEG's	When a MEG's submission is approved, the applicant receives a contract. The contract states that the organisation will be named for ToV. Upon receipt of the signed contract from the applicant the funding details are added to the disclosure tracker.
Contributions to Speaker Meetings	On approval of a speaker meeting a contract is sent to the recipient (speaker fee). The contract states that the recipient (or organisation, if the organisation supplied the recipient) will be named for ToV. Upon receipt of the signed contract from the recipient, the funding details are added to the disclosure tracker.
Contribution to 3 rd party organised events	On approval of a 3 rd party organised event a ToV Form is sent to the recipient. The Form states that the organisation will be named for ToV. Upon receipt of the Form from the organisation, the funding details are added to the disclosure tracker.
Donations	Donations are made at the discretion of the Managing Director. When the recipient of the donation submits the completed documentation back to PFL, then the details of the donation are added to the disclosure tracker.
