Bausch + Lomb UK Ltd has used its best endeavours to identify all payments to HCPs HCOs and ORDMS.

The amounts stated are transfers of value to HCP's related to calendar year 2017 1st Jan -31st Dec.

Means of identification of payments and TOV's

Payments from Bausch + Lomb UK made directly to HCP's can only be made via Purchase Order or Payment request. All such payments have been examined and considered for disclosure.

Indirect Transfers of Value to HCP's which have been paid by Bausch + Lomb to third parties such as hotels or travel companies have been identified and included in our disclosure.

Payments to UK based HCPs by overseas branches of Bausch + Lomb have also been identified and included.

All sums are excluding VAT , in most cases there is no VAT applicable when paying an HCP.

All Sums are GBP, any sums paid to an HCP or HCO in a currency other than GBP has been converted to GBP using exchange rate prevailing at the time the payment was made.

Sums paid to HCPs and HCO's may include more than one event.

All payments are made in line with fair market value and pursuant to ABPI guidelines for travel and subsistence.

Grants and Donations

Grants and donations are only paid to an institution never an individual. All grants are reviewed by a grants committee consisting of non-sales functions such as HR Regulatory and Compliance all

R&D

Bausch + Lomb UK ltd has funded one Investigator initiated study, the majority of R+D work is carried out abroad, Bausch +Lomb UK has no R+D facilities in the UK On occasion B+L oversees laboratories may consult with UK HCP's for R+D purposes, these sums are disclosed as aggregate R+D


