Syner-Med (PP) Ltd. is currently not member of ABPI, however, voluntarily agreed to abide by ABPI Code of Practice in all aspects of commercial and non-commercial activities, particularly interactions with healthcare professionals (HCPs) and healthcare organisations (HCOs). Syner-Med follows the ABPI Code of Practice with regards to any payments (Sponsorships, Registration fee, honoraria etc.) made to HCPs and HCOs in accordance to Clause 1.4, 1.5, 1.10, 4.4 10, 20, 23, 24, 28 & 29.

METHODOLOGY

Syner-Med has Policies and Standard Operating Procedures (SOP) in place in line with ABPI Code of Practice, e.g. Sponsorship/Grant Requests, Advisory Boarding, Meetings and Hospitality and all such requests are processed and approved as per relevant policies and SOPs. Honoraria for consultancy work or Advisory Board meetings etc. are calculated on Fair Market Value (FMV) based on HCPs' role, seniority, time (excluding travel times), hourly/daily rates and industry average.

Syner-Med maintains complete record of all sponsorship/grant requests and payment made to HCPs and HCOs.

In rows 10-12 disclosure template, there are no amounts to declare for HCP's for either Sponsorships, Registration, Honorarium or Travel and Accommodation expenses for 2021, this is due to the impacts of Covid 19 within the industry, Syner-Med PP Ltd received no requests for payments that would fall within this category. Total amount paid to HCP's for 2021 disclosure is £000.00.
